1. Description

The Green Municipal Fund (GMF) supports the electrification of municipal and transit fleets to help municipalities achieve net-zero transportation emissions, reducing operational and embodied GHG emissions wherever possible.GMF fund feasibility studies and capital projects to support the electrification of municipal and/or transit fleets—the transition to zero-emission vehicles (ZEVs) that have the potential to produce no tailpipe emissions, including battery-electric, plug-in hybrid electric and hydrogen fuel cell vehicles. The program funds capital projects that include:The replacement of internal combustion engine vehicles with ZEVs.The required EV supply equipment (EVSE).Any required facility upgrades to existing buildings. The program also funds studies that assess the feasibility of the transition to ZEVs that also:Consider the entire municipal and/or transit fleet.Include lifecycle total cost of ownership and GHG emission analysis.Provide options for reducing the number and size of vehicles within the fleet.Examine economic, social and other environmental impacts of the transition to ZEV. Note: Projects focused on installing EV charging infrastructure primarily dedicated to the municipal and/or transit fleet are eligible for funding
